My position on this provisions is: Oppose In Part

The reasons for my/our submission are:

The Stationmasters Way/Edward Law Boulevard corner of Prebbleton (inclusive Central Avenue, William Deans Drive and all internal roads) should be exempt from the Intensification legislation. All thoroughfares in this corner of Prebbleton are engineered with narrow roadways (often one lane each way separated by kerbing) with allocated alcove parking. This parking has capacity for approx 1 x car per every two households (400m+ sites). Housing intensification - with subsequent higher vehicle density and parking needs - would require full road reengineering or the current roading would become impassable to emergency vehicles, public transport, heavy goods vehicles and even cars and bicycles would have no or marginal accessibility around this neighbourhood because the Intensification rules do not enforce off-street parking options.

Uncontrolled intensification in this area would lead to clogged streets, no fire/ambulance access and a public transport and traffic nightmare.
