Provisions to which my/our submission relates:

My position on this provisions is: Oppose

The reasons for my/our submission are:

- 1. Private Plan Change 69 (PC69) is currently under appeal at the Environment Court, as such the process for PC69 being incorporated into the Proposed Selwyn District Plan is currently on hold until the Environment Court has made its decision.
- 2. On 4 August 2022, Lincoln Voice Incorporated, as the successor to 13 individuals who made submissions or were part of joint submissions on the plan change, lodged an appeal under Clause 14, Schedule 1 of the Resource Management Act 1991 against the decision of Council to approve the plan change request.
- 3. Lincoln Voice is concerned in respect of how Selwyn District Council has decided to incorporate PC69 in the variation that they are proposing to give effect to the Medium Density Residential Standards (MDRS), required under the Resource Management (Enabling Housing Supply and other matters) Amendment Act 2021 (EHS).
- 4. The concern is that given there are no appeal rights under the EHS for decisions on implementing the MDRS, there is the potential that the key date of 20 August 2023 will be upon us while still awaiting a hearing or decision on the Lincoln Voice appeal. And, once the MDRS decision is made, the outcome of the appeal may become moot, or at least problematic, should PC69 be modified or declined.
- 5. In the circumstances, Lincoln Voice considers that excluding PC69 from Variation 1 is the proper course and respects the natural justice rights of the community members that Lincoln Voice represents for their Appeal to the Environment Court.
